FINANCIAL REPORT TO YEAR ENDED 30 JUNE 2015

The club holds an access account with Westpac which is non-interest bearing, and at 30 June there was a balance of \$6008.94. Cash of \$100 is held as float for club night.

The Profit and Loss statement for the year ending 30 June 2015 shows that expenses exceeded income by \$89.96. Reasons for this situation can be found in the following analysis:

- Comparison with the previous two years reveals that income from club nights has decreased by 10%, while payments to guests has increased by 15%. The payment is calculated at 60% of door take, with a minimum of \$200. At the discretion of committee members, this may be increased, and this happened on several occasions. The average guest fee was \$305. This compares with the previous two years of \$260 and \$261.
- While having little financial impact, the income from acoustic nights has decreased by over 50%.
- The 25th anniversary, while being a very successful event, incurred a loss of \$380.84.

The first two items may require attention by the incoming committee.

Rental to the Horowhenua Scottish Society has remained at \$600 annually. Insurance premiums for public and statutory liability have remained at \$431.50.

Total membership last was 55 – an increase of 6 on the previous year. At time of writing, renewals for this year stand at 22.

I move that the Financial Report for the year ended 30 June 2015 of the Levin Folk Music Club Incorporated be accepted and the Financial Statement adopted.
